
當電腦正常運作或充電時，會發熱散逸到表面，變壓器在正常使用時仍可能發出高熱，因此請勿將 Eee PC 及變壓器長時間放置在膝上或是身體任一部位，並避免在過於柔軟不平的表面（如床上），或墊有軟質桌墊的桌面上使用。保持散熱孔暢通，以利散熱。



設定您的電腦

電池的安裝與取出

在使用本電腦前，請先安裝電池並接上電源變壓器，Eee PC 的電源供應方式有二種：連接變壓器與電池供應。一般在室內、家裡或辦公室使用時，建議您盡量連接變壓器使用，外出時則使用電池。


安裝電池

1. 將電池手動開關往外輕輕推開，解除電池鎖。
2. 將電腦底部朝上，將電池上有黑色凹槽的一面朝向電腦的電池凹槽，沿著電池凹槽的軌道平行緩緩的推入。讓電腦的電池凹槽上金色接腳完全沒入電池上的黑色凹槽，電池推到底後並發出「喀」一聲，電池彈簧開關會自動彈回原位。



電池若是沒有對準凹槽上的軌道會無法順利推入，請重新對準軌道再推入一次，若強行推入可能會造成電池或電腦的毀損。


3. 再將電池手動開關輕輕往內推來將電池鎖住。



全新的電池包在出廠都有部份些許餘量的電能，我們建議您在使用前先行安裝電池並對其接上 AC 變壓器進行充電，在經過數次之完全充電及耗盡電池電能的反覆使用後，電池的效能會發揮到最佳的狀態。

取出電池


1. 將電腦關機，移除所有連接線或裝置。
2. 將電腦的底部朝上，將電池手動開關往外推（如下圖 1）。
3. 將電池彈簧開關往外撥並握住開關（如下圖 2），同時使用另一隻手將電池往外拉出，即可取出電池（如下圖 3）。



當您的 Eee PC 在開機狀態時，請勿將電池拔除，否則可能會導致硬碟資料毀損。

接上電源

1. 將變壓器與交流電源插頭的電源線連接起來。
2. 將交流電源插頭接到插座上。
3. 將變壓器上的圓形插頭插入電腦後側的充電插孔。




開機

1. 打開您的 Eee PC 螢幕。



當您將螢幕打開的時候，請不要將螢幕用力往下/往後壓，這麼做可能會導致螢幕與鍵盤中間的轉軸斷裂。此外，要移動您的 Eee PC 時，請勿握住螢幕將電腦拿起。

2. 按下電源按鈕來開機。



關機


請依照以下步驟來將您的 Eee PC 關機。

2. 從彈出式的視窗中點選 關機。

當您的電腦無法從上述的方法來進行正常的關機時，請按住電腦的電源按鈕直到電腦關機為止。





觸控板的使用

觸控板介紹



觸控板的功能相當於一般電腦的滑鼠，藉由感應手指觸摸板子的壓力，以產生電壓來定位游標與下達指令。

觸控板的工作區域可以感應手指移動，您可以使用一隻手指的指腹輕輕觸摸板面，緩緩移動手指即可移動視窗上的游標位置，其下方的按鍵，左邊相當於滑鼠左鍵，可用來點選視窗上的功能或執行程式；右邊相當於滑鼠右鍵。





單手指操作說明



1. **單按/單點**：欲執行視窗某些功能時，手指略微抬起再輕觸一下板子即可，或是按一下板子下方的左鍵，這個動作相當於按一下滑鼠左鍵。



2. **雙按/雙點**：若是想要執行某個應用程式時，將游標移動至該程式的圖示上，快速連續輕觸二下觸控板，或是按二下板子下方的左鍵，這個動作相當於按二下滑鼠左鍵。




3. **拖曳**：將游標移到想要拖曳的目標上，按住左鍵不放（可用另一隻手指按住左鍵），同時移動游標位置，移到適當位置，放掉左鍵，即可完成拖曳物件。同樣的，您也可以在欲拖曳物件上輕觸兩下觸控板且手指不離開觸控板，即可利用一隻手指的動作將物件直接移到目標位置。



多手指操作說明

1. **二隻手指捲動 (Scroll)**：將二隻手指合併一起做往上/往下推或往左/往右推的動作，即可將頁面或文件往上/往下或往左/往右捲動。

首次開機

當您第一次開始使用 Eee PC 時，開機之後會自動啟動 **首次啟動精靈**，引導您建立個人化設定與輸入一些簡單的基本資料。請依照以下的步驟來完成初始化設定。

1. 第一次開機會出現授權條款版權聲明，點選 **我同意以上授權條款**，然後按 **下一步**。



2. 輸入您的使用者名稱。按 **下一步**。



3. 輸入您的密碼，並將該密碼再次輸入作為確認。按 **下一步**。



在步驟 3 中您可選擇是否勾選 **當系統啟動時自動將我登入**，若勾選這個選項，每次開機就不需要再輸入密碼確認即可直接進入畫面。若您擔心容易忘記您所設定的密碼，且本機器僅作為個人用途使用，建議您可以勾選本項目。

4. 從下拉式選單選擇時區，輸入日期、當地時間。按**下一步**。



5. 當您完成設定精靈中所有的設定步驟後，按**完成**。若想要變更設定，可以按**上一步**。
6. 電腦會重新自動開機，自動開機後若在步驟 3 沒有勾選自動登入，則此時要先輸入密碼後才能登入。



鍵盤的使用

1. 組合按鍵：鍵盤上使用彩色文字或圖像標示部分，是 Eee PC 的功能組合鍵，須同時按住鍵盤左下角的  功能鍵才會發生作用。

桌面模式

本產品為您設計貼心的桌面模式，將所有應用程式與相關的功能分為六類，分別放在各個選單中，您可以在桌面上方看到這六個選單標籤，包含有：網際網路、工作、學習、娛樂、設定、我的最愛。這個清楚的桌面分類方式讓初次使用的使用者可以很容易的操作這台電腦，也節省了使用者尋找各項應用程式所在位置的困擾。

將游標移動至選單標籤並在該標籤上用滑鼠左鍵點一下即可進入該選單，在選單中找到想要使用的程式或功能，將游標移動至該圖示，單按或雙按該圖示即可啟動程式或功能。



輸入法

當您要書寫或回覆電子郵件，或是在文書處理軟體中需要輸入文字時，可能需要切換使用其他的文字輸入法，請依照下列的方法來進行輸入法的切換。

- 您可以直接點選螢幕下方工作列上的圖示來選擇其他的輸入法。



- 您也可以按下 <Ctrl> + <Space bar> (空白鍵) 在中/英文輸入法之間切換。
- 當您切換至中文輸入法時，可以按下 <Ctrl> + <Shift>，依照您的需求選擇想要使用的中文輸入法。

電源模式

您的 Eee PC 配備有聰明的電源模式，在 **Battery Mode (電池模式)** 下，處理器會以較低的頻率運作來降低電力的消耗，可以節省電力的使用，延長電池使用的時間；若在 **AC Mode (電源模式)** 下，處理器會以全速運作，讓您可以獲得最佳的效能表現。

當您接上電源線時，Eee PC 會以 **AC Mode (電源模式)** 運作，當您移除電源線使用電池時，Eee PC 則會以 **Battery Mode (電池模式)** 運作。當您接上或移除電源線時，可以在螢幕上看到如下所示的圖示。



Super Hybrid Engine 說明

這個內建的 Super Hybrid Engine 可以讓您快速的選用電力運作模式，在不同的電力運作模式下，會影響系統運作的效能，您可以依照您的需求來選擇適合您的操作模式。

在工作列上找到如下圖的圖示，在該圖示上按一下滑鼠右鍵，依照您的需要點選使用的模式，可選用的模式有：Auto、Super Performance、High Performance、Power Saving。
