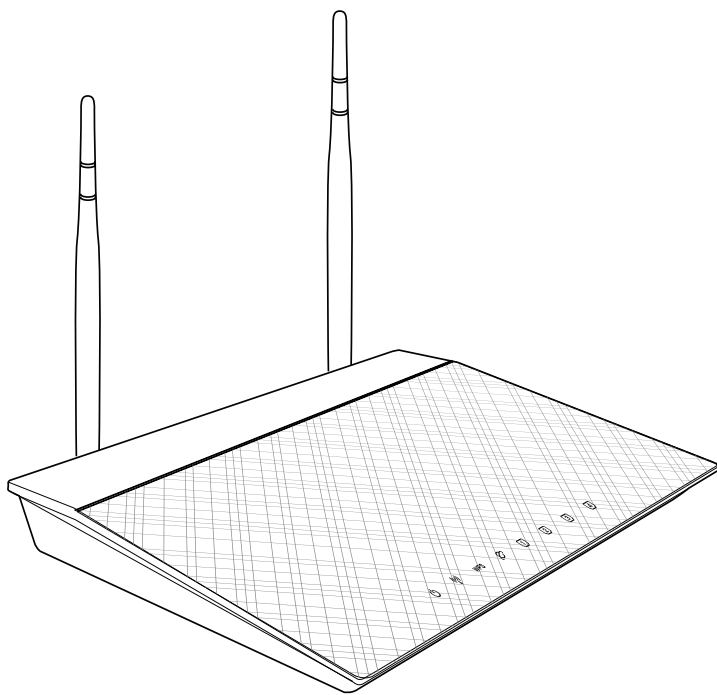

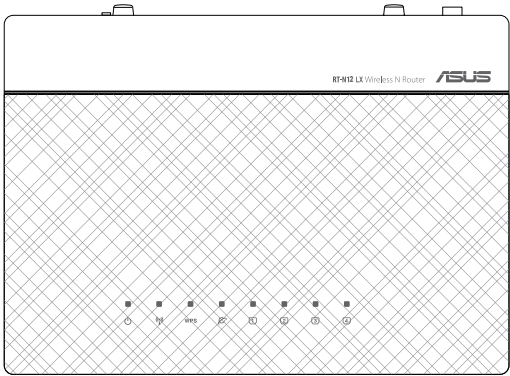
開始安裝之前

安裝華碩無線路由器之前，請注意以下幾點：

- 連接裝置與網路（網路集線器、ADSL/Cable Modem、路由器）的網路線長度須小於 100 公尺。
- 將裝置放在平坦、穩定的地方，並儘量靠近地面。
- 請勿將裝置放在靠近金屬物品與陽光直射的地方。
- 請將路由器遠離變壓器、重型發動機、熒光照明器、微波爐、冰箱與其他工業裝置以防訊號丟失。
- 建議將路由器放置在中心區域，以覆蓋所有無線行動裝置。
- 請將路由器放置在遠離人體至少 20 公分的地方。

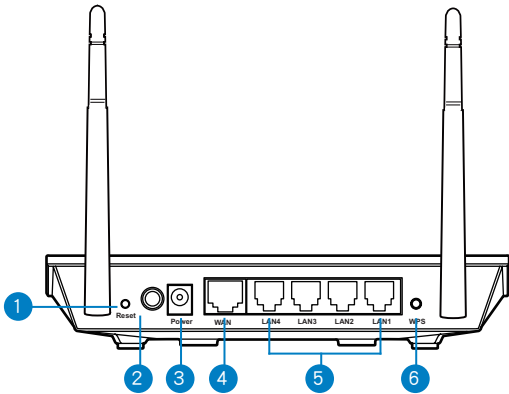

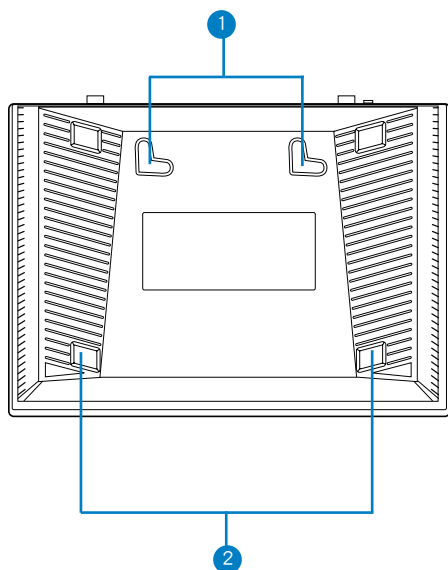

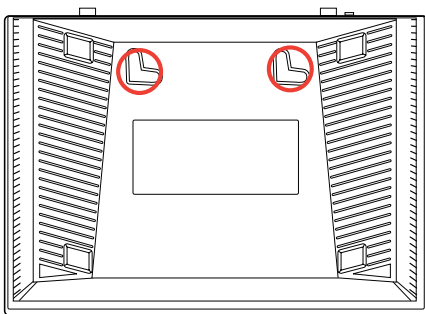

存取無線路由器

為有線或無線用戶端設定一個 IP 位址

為使用華碩無線路由器，您的有線或無線用戶端上必須有正確的 TCP/IP 設定。請確認用戶端的 IP 位址與華碩無線路由器一致。

驅動程式與公用程式光碟包含用於設定華碩無線路由器的應用程式。在 Microsoft® Windows 作業系統下安裝華碩無線路由器應用程式，請將驅動程式與公用程式光碟放入光碟機。如果未開啟“自動播放”功能，請點選驅動程式與公用程式光碟根目錄中的 `setup.exe`。

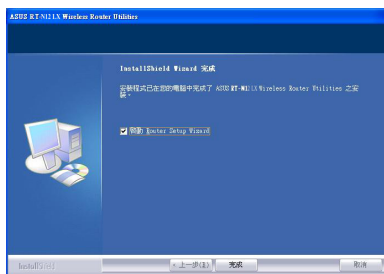

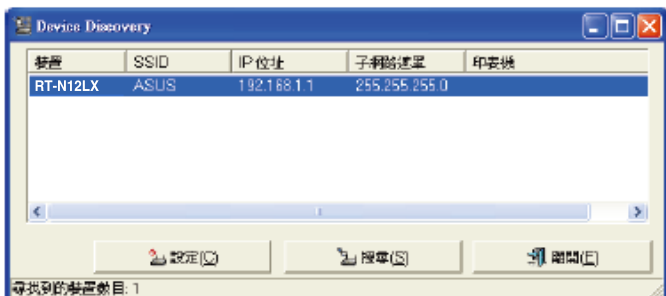


偵測裝置 (Device Discovery)

Device Discovery 是一款華碩 WLAN 應用程式，可以偵測到一個華碩無線路由器裝置，並且允許您設定該裝置。

請依照以下步驟開啟 Device Discovery 應用程式：

- 在您的電腦桌面上選擇 **開始 > 程式集 > ASUS Utility > RT-N12 LX Wireless Router > Device Discovery**。

韌體回復 (Firmware Restoration)

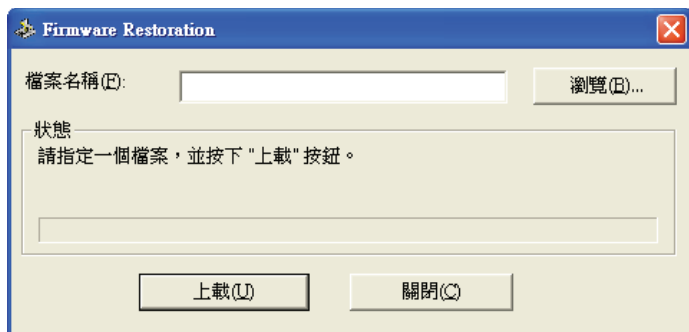
Firmware Restoration 應用程式用於在韌體更新失敗時搜尋更新失敗的華碩無線路由器。然後還原或上載您指定的韌體。此過程需要 3 至 4 分鐘。



重要：在使用 Firmware Restoration 之前，請開啟救援模式。
